Contents of this manual:

1. Registration with Cleverbase in the Cleverbase app;
2. Filling in and saving the end-user agreement;
3. Signing the end-user agreement with Cleverbase (<https://wallet.cleverbase.com/signing>);
4. Mailing the end-user agreement to Brenntag (productcompliance.nl@brenntag.com)



One-time registration with Cleverbase

You need a mobile phone for this step

During the one-time registration at Cleverbase, your identity is verified at the highest level of security. You start the identification process independently in the Cleverbase app by following these steps:

- Download the Cleverbase app in the Play Store or the App Store.
- Complete the registration in the Cleverbase app:
 - Start the registration via the open notification on the home screen;
 - Submit a photo of yourself and your identity document (ID card or passport);
 - Have a short video call with our staff
 - Confirm your details with your self-created PIN code
- Wait until the second verification is complete. You will receive a confirmation of this via email..

Fill in the end-user agreement and save as a PDF

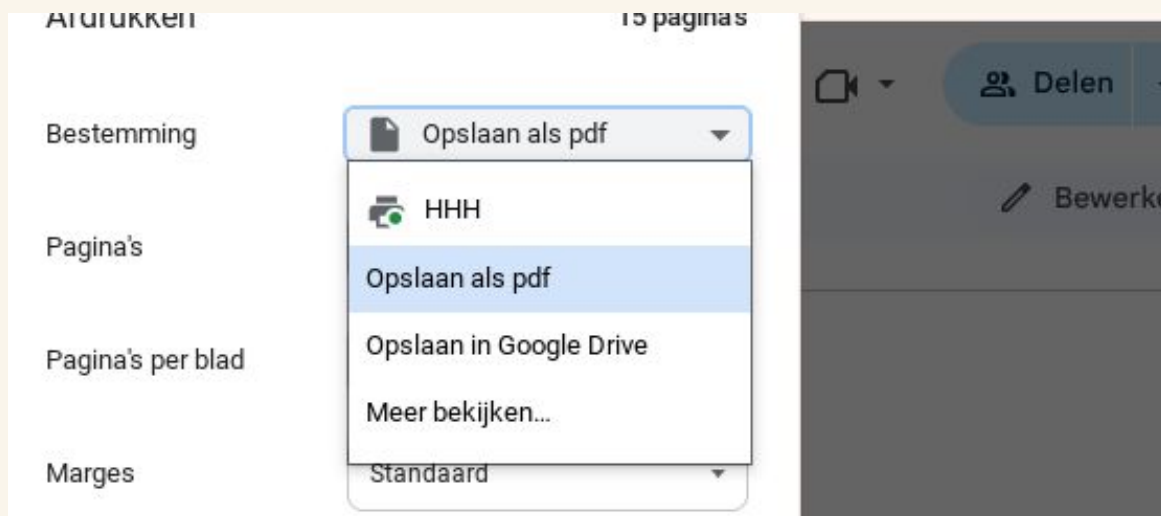
This step requires a PC/laptop

1. Fill in the Brenntag end-user agreement

- You have received an end-user agreement from Brenntag
- Fill in the empty fields digitally.

2. Save the document as a PDF

- Save the filled-in end user agreement as a PDF

2. Select file

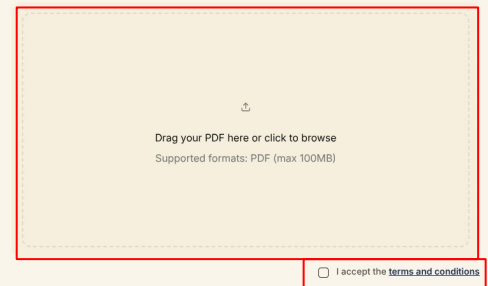
- Click on "Drag your PDF here or click to browse" and select your End-user agreement
- Accept the terms & conditions

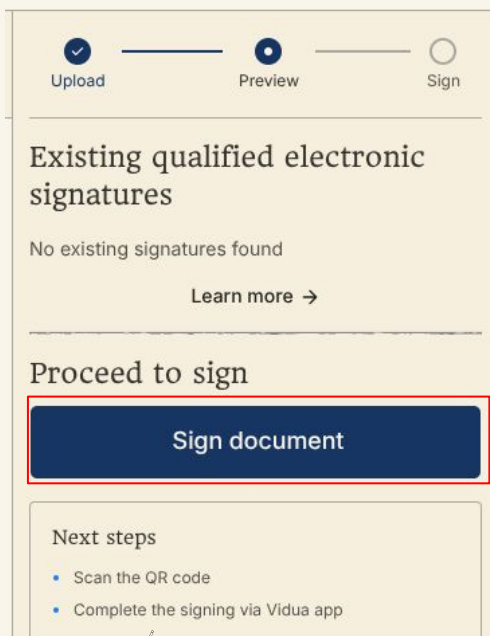

3. Scan the QR code

- Open the Cleverbase app on your telephone.
- Open the QR scanner and point it at the QR code

5. Enter your PIN code

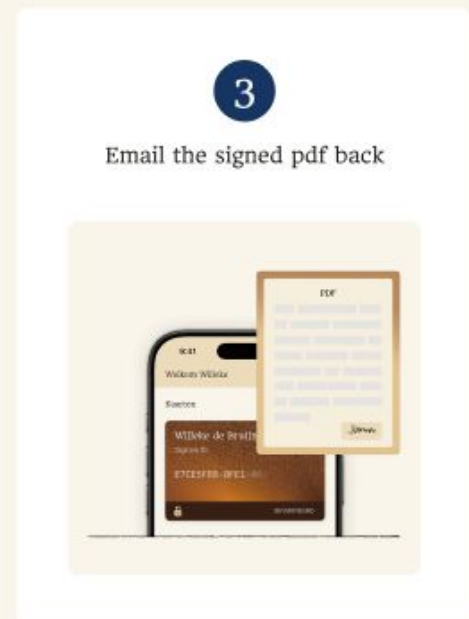
- Enter the PIN code in the Cleverbase app on your phone to place the signature.

6. Signing successful! Then download and share

- The end-user agreement now has a qualified digital signature.
- Download the document.
- Please note: the agreement has not yet been sent, do not forget to email the document to Brenntag

7. Send the signed document back to Brenntag

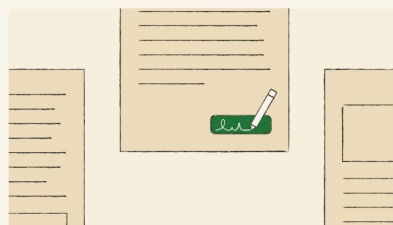
